

ACTION TAKEN REPORT 2017-18

- 1. UG Curriculum revision was made.
- IQAC conducted an Orientation Programme for Non-teaching staffs on 4th March 2017.
- 3. Student Induction Programme for the UG & PG fresher's conducted from 12 to 13 July 2017. Feedback on induction programme was taken from the students.
- 4. College Union election was conducted on 22-08-2017.
- 5. College Union inauguration was conducted
- 6. Academic Audit was conducted with the support of external experts. The reports were submitted to IQAC through the Principal.
- 7. MSc Physics's specialisation changed.
- 8. Question bank preparation was conducted.
- 9. The IQAC members finalise the format for the preparation of AQAR-2016-2017.
- 10. HRDC report was submitted.
- 11. A two-day curriculum revision workshop for teachers was conducted. The resource person was Dr. T. P. Sasikumar, Director, Shiksha. Fifty selected teachers were given training.
- 12. IQAC conducted a two day HRD Training Programme on 'Pedagogy of Mutuality' from 16th March 2018 to 17th March 2018. Dr. Meenakshi Gopinath (Director, Women in Security Conflict Management and Peace, New Delhi &Principal Emerita, Lady Shri Ram College for Women, New Delhi) and Mr. Jai Kiran K P (Head- Curriculum Development, Additional Skill Acquisition Programme, Dept. of Higher Education, Govt. of Kerala) were the resource persons for the training programme.
- 13. All Kerala Job fair was conducted in collaboration with Employment Exchange and Employability Centre on 21-10-2017.
- 14. A Board of Studies meeting was conducted on 21-01-2018.
- 15. A seminar for teaching staff was conducted on 27-01-2018 on the topic "Quality in higher education". The resource person was Dr. M. P. Rajan, Member, NAAC. All the teachers were participated in the programme.
- 16. Constituted Equal opportunity cell for physically challenged students with representation from SC/ST students
- 17. Feedback on quality initiative was taken from students, faculty alumni to take corrective measure.
- 18. PBAS documents of faculty members, whose promotion was due, were scrutinized and recommended for promotion.

- 19. Feedback on Syllabus was collected from faculty, alumni, students and employers during the current year which was analysed. The analysis report was given to the respective Boards of studies.
