

ACTION TAKEN REPORT 2018-19

- 1. Two new programme MA economics and B.Voc were introduced. B.Voc courses are B.Voc Travel, Tourism & Logistics Management and B.Voc Information Technology
- 2. Semester wise practical exams were changed to year wise from this academic year.
- 3. Research excellence awards were introduced and Awards were named after Rev. Joseph Peet.
- 4. Value-added were added to the syllabus.
- 5. Automated online MCQ exams as a part of end semester examinations.
- 6. Vocational course as open course for BA Malayalam
- 7. Medical transcription course introduced.
- 8. Student Induction Programme for the UG and PG fresher's from 28 to 30 July 2018. An entry level test was conducted at the end of Induction Programme to identify the Advanced Learners and Slow Learners. Feedback on induction programme was taken from the students.
- IQAC conducted a curriculum revision workshop for post graduate programmes on 23rd November 2018 with Dr. S Sundar Manoharan, Honourable Vice Chancellor, Sathyabhama Institute of Science and Technology (Deemed to be University) Chennai.

- 12.
