Agenda - Approval of the syllabus for M.A. Global History

This was followed by a detailed discussion and subsequently certain changes are made in the following papers

Paper - I: Introduction to Global History – The BOS suggested modifications in the contents of the first module .Accordingly in the first module is designed as Narratives of Global History: Genealogy and prehistory of globalization – archaic

globalizations – globalization in world history.



Paper – II: History of Medieval Europe

BOS recommended separate courses for Medieval World i.e., History of Medieval Europe and Civilizations in the Islamic World .

Paper –X: Gender in History : A Theoretical Perspective

In this paper BOS recommended to add contents in a world perspective

Paper-XV1: The Making of the Contemporary World

The Board changed the title from The Making of the Modern World to The Making of the Contemporary World. The Board suggested including Global Governance and Sustainable development in the content

The Board of Studies verified the list of reference books of each courses and approved it. The BOS suggested including more reference books in the syllabus.

The Board of Studies approved the presented PG Syllabus for M.A. Global History and forwarded the same to the Academic Council for approval to submit it to University.

Agenda -2-Other Matters

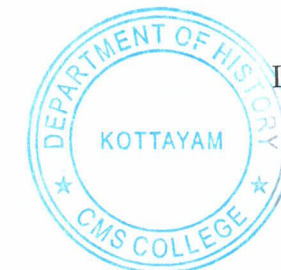
