Preparation of Academic Calendar

E-Governance

- An ERP software 'CMS Eduware' was developed exclusively by the college to automate its campus
- The attendance of students is collected by the administrative staff from teaching faculty and are entered to the software. The software then, automatically generates Monthly Reports and Semester End Reports.
- Application for Admission under UG and PG Programmes are published in the college website.

- Unique Permanent Register Number for all the students are automatically generated.
- E-books are provided to the entire faculty and students.
- Examination procedures like hall tickets with room and seat numbers generation, automated Question paper printing for each student, internal and external marks entering, semester result processing and Grade Card, Consolidated Mark list, TR are generated using software
- Feedback from students and faculty are collected using CMS-Eduware through online Feedback Management system.
- The academic success of the college is maintained through keeping a well-stocked library. The College will continue to expand its e-learning tools for the benefit of the teachers and students
- The salary bills of the employees are processed and generated using online tool 'SPARK'.
- LCD projectors/computers and WiFi connectivity were distributed and arranged in all departments in the campus.
- College Website (www.cmscollege.ac.in) was updated regularly.

Value Added Courses

Value added courses were offered to students with the aim of skill development and enhancing employability of the students.

Mentor-Mentee Programme

Mentor-mentee programme was conducted to address the personal, academic, social and emotional needs of students in the college. Mentor-mentee ratio in the college is 1:17.The newly admitted students were allotted mentors by the head of the department


IQAC Meetings

Student Induction Programme


The IQAC organised student induction programmes both for UG and PG students. Through this programme, the college officially welcomed and gave orientation to the newly joined students. The induction programme was conducted for two days in the month of October. On the first day, general orientation to the programme was given. After the address of the Principal and the inauguration address of the Bursar, the IQAC Director, Academic Dean, Student's Dean and Controller of Examinations gave a brief introduction on general aspects like quality initiatives, curriculum, student affairs and examinations etc. During the afternoon sessions, various services provided in the college were introduced to the students by the concerned coordinators and nodal officers. On the second day, functions and activities of various value added and service learning initiatives were introduced by the concerned coordinators. At the end of the day, a preference list was given to all students to choose the Value Added Servicesthey were interested to join.





Two Day Workshop on Curriculum Design

A Curriculum Design Workshop was conducted on 10th and 11thof April, 2017. Selected 50 faculty members were imparted skill for outcome based Curriculum Development. Prof. N J Rao (Visiting Professor, International Institute of Information Technology (IIIT), Banglore) was the chief resource person. The departments organised Programme Specific Workshops for UG Curriculum Revision. Continuous orientation are provided to all the faculty members regarding outcome based approach in teaching - learning process.



The two-day workshop aims at facilitating the participating faculty members to understand OBE and CBCS of UGC, design curricula of programs offered at CMS College, and write outcomes at the program level and course level that would be in alignment with NAAC Accreditation framework. A course in a general higher education program in India needs to be designed and conducted to facilitate the program to meet the identified Program Outcomes and Program Specific Outcomes identified by the Department.

- Instructional activities are designed and conducted to facilitate them to acquire the stated outcomes and they are actively engaged and challenged at the right level


