AQAR, KSHEC Data Submission

IQAC initiated data collection and processing of data for the submission of Annual Quality Assurance Report (AQAR) for the year 2020-21. The data prepared was presented before the college.

AISHE Data Submission

Annual data collection and submission to the online portal of All India Survey on Higher Education (AISHE) for the academic year was successfully completed by the IQAC.

ISO Certification

In continuation of the initiative of obtaining ISO certification for the institution as a part of its quality benchmarking process, the files were organised. Orientation classes were organised for the staff by competent resource persons with experience in ISO certification.

Preparation of Academic Calendar

The process of preparation of new academic calendar for the new academic year was taken up by the IQAC. Academic Calendar of the college was prepared taking into consideration the curricular, co-curricular and extra-curricular activities in the college and proposed examination schedules.

E-Governance

- An ERP software 'CMS Eduware' was developed exclusively by the college to automate its campus
- The attendance of students is collected by the administrative staff from teaching faculty and are entered to the software. The software then, automatically generates Monthly Reports and Semester End Reports.
- Application for Admission under UG and PG Programmes are published in the college website.
- Unique Permanent Register Number for all the students are automatically generated.
- E-books are provided to the entire faculty and students.
- Examination procedures like hall tickets with room and seat numbers generation, automated Question paper printing for each student, internal and external marks entering, semester result processing and Grade Card, Consolidated Mark list, TR are generated using software

- Feedback from students and faculty are collected using CMS-Eduware through online
 Feedback Management system.
- The academic success of the college is maintained through keeping a well-stocked library. The College will continue to expand its e-learning tools for the benefit of the teachers and students
- The salary bills of the employees are processed and generated using online tool 'SPARK'.
- LCD projectors/computers and WiFi connectivity were distributed and arranged in all departments in the campus.
- College Website (www.cmscollege.ac.in) was updated regularly.

Participation in the NIRF Ranking 2021

Determined to prepare in a way that would enable a better rank to be achieved in the NIRF ranking from the previous year, a proforma was supplied to the department and to every academic and extracurricular organisation to generate data for the same. Data about the institution, the professors, and the students were gathered with the assistance of DQAC and IQAC core team members.

Value added courses were offered to students with the aim of skill development and enhancing employability of the students.

Mentor-Mentee Programme

In the context of covid, mentor-mentee programme was conducted in online mode to address the personal, academic, social and emotional needs of students in the college. The newly admitted students were allotted mentors by the head of the department

Programmes organised by IQAC

Five-Day Faculty Development Programme

The Internal Quality Assurance Cell of CMS College Kottayam organized Five-Day Faculty Development Programme on 'NAAC Assessment and Accreditation Process in the Revised Accreditation Framework', under UGC PARAMARSH Scheme from 7th June 2021 to 11th June 2021 via Microsoft Teams in order to give a detailed insight and analysis of each criterion of the NAAC assessment and accreditation. The Faculty Development Programme also aims at a detailed discussion and analysis of the Revised Accreditation Framework.


The FDP started with a prayer followed by the welcome speech by Dr. Joji John Panicker, Director of IQAC. Dr. Varghese C Joshua, Principal of CMS College Kottayam (Autonomous) gave the inaugural speech, which was followed by the first session led by Dr. C James, Associate Professor of Physics & Dean of IQAC, Scott Christian College (Autonomous), Nagercoil, who was the resource person.

On the first day (4th June 2021) of the FDP, Dr. C James gave a detailed insight of the first criterion of the seven criteria by NAAC. The first criteria which dealt with the curricular aspects was discussed in detail and informed the faculty about the role of the college in preparing it. In the interactive session which followed the first session, the participants did get an explanation regarding the consolidation of data. On day two (7th June 2021) of the programme the second criterion, Teaching-Learning and Evaluation was discussed and analysed in detail. Criterion group members as well as others actively participated in the discussion. On the third day (8th June 2021) of the programme, the discussion and analysis was on the third criterion, which is Research, Consultancy and Extension. On June 9th, the fourth day of the FDP, the resource person talked about the fourth criterion that is the Infrastructure and Learning Resources, in detail. On the fifth day (10th June) of the programme, the topic of discussion and analysis was Student Support and Progression, which is the fifth assessment criterion in accreditation. Sixth day of the programme, which was on 11th June, discussed the sixth criteria, which is Governance, Leadership and Management. On

the last day of the FDP, June 14th, the discussion and analysis was on the seventh criterion, which is Innovations and Best Practices. There were analyses of each criterion data consolidated and prepared by the college. The areas needed to improve for a better score were identified. Strategies for development and improvement were noted down after discussion at the end of each session. All the teachers and non teaching staff of the college actively participated in the workshop. The participants also shared their experiences and difficulties faced during the process of data compilation. Dr. C. James clarified the doubts and problems pointed by the participants. The workshop gave an opportunity for meaningful and fruitful discussion.











Inter-Disciplinary Two-Week Online Refresher Course/ Faculty Development Programme

The CMS College Kottayam (Autonomous) in collaboration with Teaching Learning Centre Ramanujan College, University of Delhi, under the aegis of Ministry of Education, Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching organised a Inter-Disciplinary Two-Week Online Refresher Course/ Faculty Development Programme Managing Online Classes & Co-Creating MOOCS 7.0 from 5th August 2021 to 19th August 2021. The FDP helped in equipping the faculty members in developing short learning object as MOOC content in their own subject area and to deliver these materials in a technological platform.

The first session was the concept of creating e-content and the underlying technology and proficiency. In the following sessions, teachers were taught about the use of open tools, video creation software and how to make an effective video editing, advanced technique for teaching pedagogy. A briefing on assessment tools and techniques, online assignments and quizzes were also discussed. The FDP was really informative and helpful for effective implementation of online courses.

NEP stipulates that the NHEQF will be formulated and it shall be in sync with the National Skills Qualifications Framework (NSQF) so as to ease the integration of vocational education into higher education, prescribe the facilitative norms for issues such as credit transfer, equivalence, etc. NHEQF will integrate skilling with general education and it will have synergy and continuity with NSQF (National Skills Qualification Frameworks) and will make it possible for Multiple Entry and Exit Scheme in Academic Programmes Offered in Higher Education. 




The purpose of the draft is to invite and collect public feedback and suggestions by 13 February 2022. This webinar intends to discuss the NHEQF in detail so as to enable the stakeholders of higher education institutions to provide feedbacks and suggestions.
